ORDINANCE NO. 118

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ANGUS, TEXAS AMENDING THE CITY'S BUILDING CODE AND ORDINANCE NO. 109 IN ORDER TO REGULATE NEW BILLBOARD SIGNS WITHIN THE CITY OF ANGUS, PROVIDING FOR A GENERAL PENALTY FOR VIOLATIONS, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City Council of Angus hereby desires to protect the visual aesthetics along its streets, road, and highways within the city limits;

WHEREAS, the City Council does not want to prohibit the replacement or upgrading of old and deteriorated billboard signs that are lawful and currently in existence, now therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ANGUS, TEXAS:

ARTICLE 1. Chapter 2301.8(b) of the Standard Building Code shall be amended to read as:

(b) From the effective date of this ordinance, no new billboard sign shall be erected or installed in the City of Angus, except that all lawful billboard signs currently in existence that are located within the city limits as of the effective date of this ordinance shall continue to be allowed.

Also, any existing or newly permitted billboard sign that is lawfully in existence as of the effective date of this ordinance shall be allowed to be replaced or upgraded with another similar billboard sign provided the new billboard sign complies with all ordinances and laws of the City of Angus and the State of Texas. No single billboard sign may be upgraded to a double billboard sign ~~shall be allowed~~.

ARTICLE 2. GENERAL PENALTY FOR VIOLATIONS

That any person violating this ordinance shall be guilty of a misdemeanor and said offense is punishable by fine in any sum not to exceed five hundred dollars (\$500.00) per occurrence.

ARTICLE 3. SEVERABILITY CLAUSE

That should any article or section of this ordinance be decreed to be void by a court-of-law, the invalidity of such article or section shall not affect the validity of the remaining portions of this ordinance and that each article and section or portion thereof not decreed to be invalid shall remain valid and enforceable.

ARTICLE 4. CONFLICTING ORDINANCES REPEALED

That all ordinances or parts of ordinances that are in conflict with this ordinance are hereby repealed.

ARTICLE 5. EFFECTIVE DATE

This ordinance shall take effect immediately upon its passage and publication as the law requires.

Notification To Private Schools And Home Schools

**To:** Any Private School or Home School Concerned  
**From:** Freestone-Navarro Bi-County Special Education Coop  
**Re:** Invitation to Participate in IDEA Funded Programs for Children with Disabilities Voluntarily Enrolled in Private Schools

The purpose of this notice is to notify you of the conditions under the Individuals with Disabilities Education Act (IDEA) through which special education and related services may be provided to children with disabilities voluntarily enrolled by their parents in private schools, including religious and home schools.

**Child Find**  
The Freestone-Navarro Bi-County Coop has a child find system for identifying, locating and evaluating all children with disabilities attending private schools, regardless of the severity of their disabilities and who are in need of special education and related services.

If you have a child or children whom you suspect of being disabled, you may initiate a referral for a full and individual evaluation by notifying Ernest Pack, Director of the Bi-County Coop at 903-389-3372.

Children who have not been identified through the child find process and determined to be eligible for special education and related services by an Admission, Review and Dismissal (ARD) committee cannot be included in the determination of services described below.

**Services to Parentally Placed Private School Children with Disabilities**  
The law does not require that services be provided to all children with disabilities voluntarily enrolled in private schools, or to every private school. However, every effort will be made to provide appropriate services with proportionate IDEA funds. By contacting us you will assist us in our effort to accurately count all IDEA eligible children enrolled in private schools and to determine how best to use the proportionate share of IDEA funds to meet the needs of children with disabilities voluntarily enrolled in private schools.

If your school has a child or children with disabilities for whom you are now providing basic instructional services and who are in need of special education services, please contact Ernest Pack at 903-389-3372. After we receive your call, we will contact you to discuss the needs of the IDEA eligible child/children enrolled in your school.
