

City of Angus, Texas  
Ordinance No. 142

AN ORDINANCE OF THE CITY OF ANGUS, TEXAS AMENDING THE ZONING OF CERTAIN PROPERTY OWNED BY TRACY CROTEAU CONSISTING OF 2.424 ACRES SITUATED IN THE JOHN MCNEAL SURVEY, FROM RESIDENTIAL 2 TO COMMERCIAL 2 DISTRICT; REPEALING CONFLICTING ORDINANCES AND CODE PROVISIONS; PROVIDING FOR SEVERABILITY; AND ESTABLISHING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ANGUS, TEXAS:

**SECTION 1:** That the zoning for certain property owned by Tracy Croteau as further described hereinafter is hereby changed from Residential (R-2) to Commercial (C-2). The legal description for such property is more fully described as follows:

BEING a tract of land in the John McNeal Survey, Abstract No. 8, Navarro County, Texas and being all of that certain tract of land conveyed to the Secretary of Housing and Urban Development as evidenced by deed recorded in Volume 1672, page 289 of the Deed Records of Navarro County, Texas and being more particularly described as follows:

BEGINNING at an iron bar found in Bonner Avenue (county Road SW 0020) and the west line of the Southern Pacific Railroad;

THENCE South 27°39'13" East along the west line of the Southern Pacific Railroad a distance of 459.89 feet to a ½-inch iron rod found for the northeast corner of that certain 5.694 acre tract of land conveyed to Alfred Brown as evidenced by deed recorded in Volume 1562, Page 729 of the Deed Records of Navarro County, Texas;

THENCE South 45°00'00" West departing the west line of the Southern Pacific Railroad a distance of 241.04 feet to a ½-inch iron rod found in the east line of that certain tract of land conveyed to Dicky Joe Brown and wife, Jamie M. Brown as evidenced by deed recorded in Volume 1256, Page 380 of the Deed Records of Navarro County Texas for the most northerly northwest corner of said Brown 5.694 acre tract;

THENCE North 27°33'00" West a distance of 459.71 feet to a 5/8-inch iron rod set in Bonner Avenue (County Road SW 0020) for the northeast corner of that certain 1.568 acre tract of land conveyed to Alfred Brown as evidenced by deed recorded in Volume 1427, Page 835 of the Deed Records of Navarro County, Texas;

THENCE North 44°54'00" East a distance of 240.30 feet to the POINT OF BEGINNING; CONTAINING within the metes recited 2.424 acres of land, more or less;

**SECTION 2:** That it is hereby declared to be the intention of the City Council that the sections, paragraphs, sentences, clauses and phrases of this ordinance are severable and, if any phrase, clause, sentence, paragraph or section of this ordinance shall be declared unconstitutional by the valid judgment or decree of any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this ordinance, since the same

would have been enacted by the city council without the incorporation in this ordinance of any such unconstitutional phrase, clause, sentence, paragraph or section.

**SECTION 3:** All provisions of the Angus Code or Ordinances, any other ordinances or parts of ordinances in conflict herewith are, to the extent of such conflict, hereby repealed.


**SECTION 4:** This ordinance shall take effect immediately from and after its passage and the publication of its caption, as the law in such cases provides.



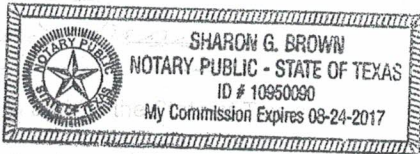
