

ORDINANCE # 164

AN ORDINANCE GIVING MAYOR AUTHORITY TO APPOINT A MUNICIPAL JUDGE FOR A TWO-YEAR TERM; PROVIDING THAT THIS ORDINANCE SHALL BE CUMULATIVE; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Council established a Municipal Court;

WHEREAS, the City Council set two year terms for each municipal judge.

WHEREAS, the Mayor desires to appoint a municipal judge.

BE IT ORDAINED BY THE CITY COUNCIL FOR THE CITY OF ANGUS, TEXAS:

Section 1

That a Municipal Judge is appointed for a two-year term.

Section 2

This ordinance shall be cumulative of all provisions of ordinances and the City of Angus, Code of Ordinances, as amended, except where provisions of this ordinance are in direct conflict with the provisions of such ordinances and Code, in which event such conflicting provisions of such ordinances and Code are hereby repealed.


Section 3

It is hereby declared to be the intention of the City Council that the sections, paragraphs, sentences, clauses and phrases of this ordinance are severable, and, if any phrase, clause, sentence, paragraph or section of this ordinance shall be declared void, ineffective or unconstitutional by the valid judgment or final decree of a court of competent jurisdiction, such ineffectiveness or unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this ordinance, since the same would have been enacted by the City Council without the incorporation herein of any such void, ineffective or unconstitutional phrase, clause, sentence, paragraph or section.


Section 4
