AN ORDINANCE AMENDING THE CITY OF ANGUS CODE OF ORDINANCES, ORDINANCE 5, ARTICLE III, SECTION 1 RESIDENCE DEFINED TO ADD SUBSECTION (h) AND TO ADD CHAPTER 36 RVs NOT LOCATED IN AN RV PARK TO THE CITY OF ANGUS CODE OF ORDINANCES TO READ: NO RV/TRAVEL TRAILER/MOTOR HOME PARKED ON PROPERTY WITHIN THE CITY LIMITS OF ANGUS SHALL BE USED AS A RESIDENCE; HOWEVER, IT MAY BE USED FOR GUESTS FOR A MAXIMUM OF 10 DAYS; PROVIDING THAT THIS ORDINANCE SHALL BE CUMULATIVE; PROVIDING A SEVERABILITY CLAUSE; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, RVs/Travel Trailers/Motorhomes are not allowed to be used as residences within the City of Angus, and

WHEREAS, the City of Angus has determined that the Code of Ordinannces, Ordinance 5, Article III, Section 1 Residence Defined be amended and The City of Angus, Code of Ordinances shall be amended to add Chapter 36 RV's NOT LOCATED IN AN RV PARK.

BE IT ORDAINED BY THE CITY COUNCIL FOR THE CITY OF ANGUS, TEXAS:

Section 1

That Ordinance 5, Article III, Section 1 Residence Defined be amended to add Subsection (h) and Chapter 36 be added to the City of Angus Code of Ordinances to add the following:

RVs/Travel Trailer/Motor homes within the City of Angus shall not be used as a residence as previously outlined in Ordinance 5, Article III; however, they may be used to temporarily house guests for a maximum of 10 days.

Section 2

This ordinance shall be cumulative of all provisions of ordinances and the City of Angus, Code of Ordinances, as amended, except where provisions of this ordinance are in direct conflict with the provisions of such ordinances and Code, in which event such conflicting provisions of such ordinances and Code are hereby repealed.

Section 3

It is hereby declared to be the intention of the City Council that the sections, paragraphs, sentences, clauses and phrases of this ordinance are severable, and, if any phrase, clause, sentence, paragraph or section of this ordinance shall be declared void, ineffective or unconstitutional by the valid judgment or final decree of a court of competent jurisdiction, such ineffectiveness or unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this ordinance, since the same would have been enacted by the City Council without the incorporation herein of any such void, ineffective or unconstitutional phrase, clause, sentence, paragraph or section.

Section 4

This ordinance shall be in full force and effect from and after its passage, and it is ordained.
