## CITY OF ANGUS, TEXAS

ORDINANCE NO. 42

AN ORDINANCE AMENDING AND CHANGING THE OFFICIAL ZONING MAP OF THE CITY OF ANGUS SO AS TO PROVIDE FOR A SPECIAL USE PERMIT.

WHEREAS, the application for a specific use permit having been applied for by Kenneth Folmar, the owner of property, the application fee having been paid, the surrounding property owners having been notified, notice of public hearing having been published, public hearing having been held, and at least thirty (30) days having elapsed since notification to property owners;

NOW THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ANGUS, TEXAS:

That in accordance with the Angus Code of Ordinances, Chapter 11, Section 9, A Special Use Permit is hereby granted as follows:

1. Uses permitted:

Recreational Vehicle Park and Mobile Home Park

2. Conditions under which granted:

Compliance with City of Angus Mobile Home Park Regulations and Subdivision Regulations

That the Special Use Permit shall be applicable to the following described property:

(See Exhibit A description of property attached.)

That the Zoning Map of the City shall be amended to provide for the above specific use permit on the above described property.
