ORDINANCE NO. <u>68</u>

AN ORDINANCE OF THE CITY OF ANGUS, TEXAS, ADDING SECTION 10 OF CHAPTER 3 OF THE CODE OF ORDINANCES SPECIFICALLY **INCLUDE** CODE DEFINITIONS TO OFFICER AND CITY, AMENDING THE SIZE OF MOBILE AND SPACING CLEARANCE PARKS, HOME REQUIREMENTS FOR MOBILE HOMES, AND OFF-STREET PARKING REQUIREMENTS TO CONFORM WITH THE ORDINANCE; **PROVIDING** ZONING CITY'S SEVERABILITY; REPEALING ANY ORDINANCES; AND PROVIDING FOR AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ANGUS, TEXAS:

ARTICLE I

That Section 10 of Chapter 3 of the Code of Ordinances be amended as follows:

Section 10: Mobile Home Parks

A. DEFINITIONS

The following words, when used in this seciton, shall have the meaning respectively ascribed:

- (1) Code enforcement officer shall mean a person authorized by the mayor or city council to perform the duties prescribed in this section.
- (2) (8) ...
- (9) City shall mean the City of Angus, Navarro County, Texas.

F. MOBILE HOME PARK DESIGN AND CONSTRUCTION STANDARDS

All mobile home parks shall meet the following design and construction standards:

(1) Size of Park; Spacing and Clearances for Mobile Homes

The minimum size of a mobile home park and the spacing and clearances requirements of mobile home parks shall be as provided for in the city's zoning ordinance.

(2) Off-street Parking Spaces

The off-street parking requirements shall be as provided for in the the city's zoning ordinance.

ARTICLE II

That anywhere in Section 10 of Chapter 3 where it refers to "town" it shall be amended to read as "city."

ARTICLE III

That is is hereby declared to be the intention of the city council that the sections, paragraphs, sentences, clauses and phrases of this ordinance are severable and, if any phrase, clause, sentence, paragraph or section of this ordinance shall be declared unconstitutional by the valid judgment or decree of any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this ordinance, since the same would have been enacted by the city council without the incorporation in this ordinance of any such unconstitutional phrase, clause, sentence, paragraph or section.

ARTICLE IV

All ordinances or parts of ordinances in conflict herewith are, to the extent of such conflict, hereby repealed.

ARTICLE V

This ordinance shall take effect immediately from and after its passage and the publication of its caption, as the law in such cases provides.


