ORDINANCE NO. 82

AN ORDINANCE OF THE CITY OF ANGUS, TEXAS ADDING SECTION 5 OF CHAPTER 9 OF THE CODE OF ORDINANCES SPECIFICALLY BY ESTABLISHING STOP INTERSECTIONS AT KNIGHT STREET AND BONNER AVENUE AND AT LATTA STREET AND BONNER AVENUE; PROVIDING FOR SEVERABILITY; REPEALING CONFLICTING ORDINANCES OR PROVISIONS; PROVIDING FOR A PENALTY NOT TO EXCEED TWO HUNDRED DOLLARS (\$200.00) FOR VIOLATIONS; AND PROVIDING FOR AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ANGUS, TEXAS:

ARTICLE I

That Section 6 of Chapter 9 of the Code of Ordinances be added to include the following:

Section 6: Stop Intersections

It is hereby provided that stop signs shall be erected at the following intersections and such intersections are hereby designated as stop intersections. Every driver of a vehicle shall stop at the point nearest the intersecting roadway where the driver has a view of approaching traffic on the intersecting roadway before entering the intersection, and shall not proceed until it is safe to do so or unless otherwise directed by a police officer. The designated stop intersections are:

- (D) Knight Street at Bonner Avenue All traffic on Knight Street entering onto Bonner Avenue shall stop and yield to oncoming traffic.
- (E) Latta Street at Bonner Avenue All traffic on Latta Street entering onto Bonner Avenue shall stop and yield to oncoming traffic.

Any person failing to stop at any stop intersection and then proceed only when it is safe to do so shall be guilty of a misdemeanor.

ARTICLE II

Any person violating any of the provisions of this ordinance shall be deemed guilty of a misdemeanor, and upon conviction, shall be subject to a fine of not more than two hundred dollars (\$200.00). Furthermore, each and every day any such violation of this ordinance shall continue it shall constitute a separate offense.

ARTICLE III

That is is hereby declared to be the intention of the city council that the sections, paragraphs, sentences, clauses and phrases of this ordinance are severable and, if any phrase, clause, sentence, paragraph or section of this ordinance shall be declared unconstitutional by the valid judgement or decree of any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences,

paragraphs and sections of this ordinance, since the same would have been enacted by the city council without the incorporation in this ordinance of any such unconstitutional phrase, clause, sentence, paragraph or section.

ARTICLE IV

All ordinances or parts of ordinances in conflict herewith are, to the extent of such conflict, hereby repealed.

ARTICLE V




