# ordinance no. 93

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ANGUS, TEXAS AMENDING ORDINANCE NO. 4 AND AMENDING ORDINANCE NO. 29 ADOPTED JUNE 13, 1983 BY REQUIRING THAT THE ANGUS WATER SUPPLY CORPORATION SUBMIT ANY INCREASE IN RATES AND CHARGES TO THE CITY OF ANGUS FOR APPROVAL BEFORE CHARGING OR BILLING ITS CUSTOMERS FOR SUCH.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ANGUS, TEXAS THAT:

#### ARTICLE I

THAT SECTION 3 OF THE ANGUS WATER SUPPLY CORPORATION FRANCHISE BE AMENDED AS FOLLOWS:

SECTION 3. The grantee shall, at its own cost and without expense to any of its customers or prospective consumers, wherever permanent improvements are located on the premises of such consumer or prospective consumer, construct and maintain service of proper size and capacity from its existing facilities to the property line of each consumer or prospective consumer, upon demand of such consumer or prospective consumer; but the grantee shall be entitled to charge and collect from such consumer or prospective consumer an installation fee for installing a service connection from such property line to its meter. Said installation or connection fee shall be in accordance with the approved schedule of fees and charges. It is provided, however, that should grantee desire at any time thereafter to change the point of service to any consumer, such change in the service from the property line to the house necessitated by such change of service connection shall be borne by grantee.

### ARTICLE II

THAT SECTION 8 OF THE ANGUS WATER SUPPLY CORPORATION FRANCHISE BE AMENDED AS FOLLOWS:

SECTION 8. Grantee, through the life of this ordinance, agrees to furnish inhabitants residing within the city limits of Angus, Texas, treated water sold and distributed by grantee hereunder in accordance with the approved service rate and fee schedule filed with and approved by the City Council of the City Angus. In no event shall the residents of Angus be charged higher rates and charges than other like or similar being served by Angus Water Supply Corporation. All requests for increases in rate and other service fees must be submitted to the City of Angus at least sixty (60) days before such increase is proposed to go in effect.
