SUCH PROPERTY SHALL BE ZONED FROM RESIDENTIAL-2 DISTRICT TO COMMERCIAL DISTRICT; REPEALING CONFLICTING ORDINANCES AND CODE PROVISIONS; PROVIDING FOR SEVERABILITY; AND ESTABLISHING AN EFFECTIVE DATE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ANGUS, TEXAS:

Section 1: That the zoning for certain property owned by W. B. Hanna as further described hereinafter and in the preamble is hereby changed from Residential-2 District to Commercial District. The description for such property is more fully described as follows:

Beginning at an iron stake for corner set in the northwest corner of O.E. Crespo tract, and the northeast corner of W. B. Hanna tract and also the south R.O.W. of F.M. No. 739; thence north 45°30' east 282 feet with said line to an iron stake for corner set in the south R.O.W. of F.M. No. 739; thence south 44°30' east 311.14 feet with said line to an iron stake for corner; thence south 45°30' west 282 feet to an iron stake for corner; thence north 44°30' east 311.14 feet to the place of beginning containing 2.01 acres more or less of land.

Section 2: That it is hereby declared to be the intention of the City Council that the sections, paragraphs, sentences, clauses and phrases of this ordinance are severable and, if any phrase, clause, sentence, paragraph or section of this ordinance shall be declared unconstitutional by the valid judgement or decree of any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this ordinance, since the same would have been enacted by the city council without the incorporation in this ordinance of any such unconstitutional phrase, clause, sentence, paragraph or section.

Section 3: All provisions of the Angus Code of Ordinances, any other ordinances or parts of ordinances in conflict herewith are, to the extent of such conflict, hereby repealed.

Section 4: This ordinance shall take effect immediately from and after its passage and the publication of its caption, as the law in such cases provides.
