### Ordinance No. 99

AN ORDINANCE OF THE CITY OF ANGUS, TEXAS AMENDING THE ZONING OF CERTAIN PROPERTY OWNED BY KAREN BODINE FOR TRACT NO. 33 IN THE SHADY CREEK SUBDIVISION, FROM RESIDENTIAL 2 TO PLANNED DEVELOPMENT DISTRICT; REPEALING CONFLICTING ORDINANCES AND CODE PROVISIONS; PROVIDING FOR SEVERABILITY; AND ESTABLISHING AN EFFECTIVE DATE.

### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF ANGUS, TEXAS:

Section 1: That the zoning for certain property owned by Karen Bodine as further described hereinafter is hereby changed from Residential-2 District to Planned Development District. The legal description for such property is more fully described as follows:

All that certain lot, tract or parcel of land being 5.880 accres and being Tract No. 33 of the Shady Creek Subdivision in the P. J. Borrow Survey, Abstract No. 110 in Navarro County and being a part of a called 57.9 acres described in deed from Mrs. E. E. Crumbley to G T & T Inc. dated August 1, 1984 and recorded in Volume 1034, Page 85 of the deed records of Navarro County.

The planned development for the property will be limited to no more than two mobile homes. The location and placement of the mobile homes shall be presented to the Mayor in the form of a site (or development) plan for his approval as a condition of the passage of this ordinance. Failure to render this site (or development) plan in accordance with the zoning ordinance will render this ordinance invalid.

Section 2: That it is hereby declared to be the intention of the City Council that the sections, paragraphs, sentences, clauses and phrases of this ordinance are severable and, if any phrase, clause, sentence, paragraph or section of this ordinance shall be declared unconstitutional by the valid judgement or decree of any court of competent jurisdiction, such unconstitutionality shall not affect any of the remaining phrases, clauses, sentences, paragraphs and sections of this ordinance, since the same would have been enacted by the city council without the incorporation in this ordinance of any such unconstitutional phrase, clause, sentence, paragraph or section.

Section 3: All provisions of the Angus Code of Ordinances, any other ordinances or parts of ordinances in conflict herewith are, to the extent of such conflict, hereby repealed.

Section 4: This ordinance shall take effect immediately from and after its passage and the publication of its caption, as the law in such cases provides.
