Ken Cook made a motion to amend the ordinance to change the official depository of the City of Angus from Corsicana National Bank to Community National Bank. Motion was seconded by Becky Henderson. Motion carried by unanimous vote.

- **ITEM # 6** – Discuss and consider an increase in the sewer rates. Take action if necessary.

Becky Henderson made a motion to increase the sewer rates for residential customers from \$35.00 per month to \$40.00 per month and to increase the base rate for commercial/business customers from \$60.00 per month to \$65.00 per month. Motion was seconded by Ken Cook. Motion carried by unanimous vote.


